

#### Purpose, objectives and elements of event

The round table was held at SUM as part of the congress on waste disposal. The aim of the Round Table was to improve cooperation with stakeholders from the real sector in the management and monitoring of aquatic ecosystems.

The title of the round table was "Challenges of waste disposal and preservation of aquatic ecosystems". The main task of the round table was waste, which is a global problem today, but also a burning problem in Bosnia and Herzegovina, Inadequately disposed waste on the karst of Herzegovina in the immediate vicinity of intact water ecosystems is particularly dangerous.

In addition to professors from FPMOZ, the participants of the round table were also representatives of the Adriatic Sea Water Agency, Federal Ministry of Tourism and Environment, NGO "Lijepa naša Čapljina", Environmental Protection Fund of the Federation of BiH, Office of the Mayor of Čapljina and representatives of WWF Adria. During these events the benefits of ECOBIASNET platform for stakeholders were explained, together with the effect of the improvement in knowledge/skills in EMAB.

#### CONCLUSIONS

The Round Table was extremely successful. The main objectives of the Round Table were to improvement of participants from real sector, NGOs and various state agencies in the management of water ecosystem. The main emphasis is on inadequate waste management. A significant danger is represented by inadequately disposed waste on the karst of Herzegovina. In addition to inadequate disposal of waste, the biggest problem is represented by many wild landfills, which represent an immediate and significant danger for the water regime of this area, especially for natural water ecosystem

The main conclusion was the need for further gatherings for the purpose of mutual development of cooperation in the care of environment and nature preservation. One of the main conclusion is the preservation of aquatic ecosystems, which are among the first to be affected by inadequate waste disposal.

The participants of the Round table particularly showed interest in new ways of disposing of waste and what are the best ways to manage water ecosystems. Also, the participants were shown the close connection between inadequate waste disposal, the impact on the nearby water ecosystem and ultimately on human health, which led to a new understanding of things and finding solutions.

It was also concluded that such events are a good option for future cooperation on new projects in water protection and sustainable management of aquatic ecosystems.
